Precaster Membership Requirements

Master Precaster

To be awarded Master Precaster status, you must have been manufacturing precast for 5+ years. Master Precasters must pass a **Master Precaster Audit.** This audit verifies your industry contribution and track record, as well as your technical and factory capability, your quality and safety management and your environmental compliance.

Services ONLY available to Master Precasters

- Promote yourself as a Master Precaster.
- Meet with authorities.
- Receive an Improvement Report (identifying practical opportunities to improve QS&E management).

Precaster

To become a Precaster member you must have been manufacturing precast for 2+ years.

PP Provisional Precaster

Provisional Precaster members must be new to the business and have only been manufacturing precast for less than 2 years. After 2 years of membership, you'll need to apply for Precaster membership.

AP Affiliate Precaster

For a minimal cost, being an Affiliate Precaster allows precasters to experience some of the benefits of membership, being kept up to date with industry news and having a say in changes with standards, codes and authorities.

Membership Fees

Fees are based on ex-works turnover (excludes cartage, installation and GST). They can be paid in full or in quarterly installments by arrangement. Fees are treated as STRICTLY CONFIDENTIAL by the CEO and accounts staff.
